4.1. Description of First Aid Measures

SECTION 5: FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

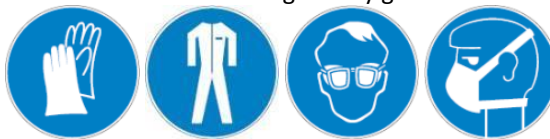
